Wishes to engage a contractor to implement the following

1. The Royal Government of Cambodia (RGC) has received a loan from the Asian Development Bank (ADB) toward the cost of Technical Vocational Education and Training Sector Development Project (TVETSDP) and it intends to apply part of the proceeds of this loan, ADB Loan No. 3167-CAM (SF) to payment for the Rehabilitation Works for CoE at PPI, (TVETSDP/CW-05-O-SHP-Lot 3).
2. Rehabilitation Works for CoE at PPI will begin on **20 October 2018** and will be completed by end of **22 April 2019**.
3. Interested qualified eligible contractors are invited to request a copy of the bidding documents free of charge from the address given below.
4. To be considered eligible and qualified a contractor must
 - a. Be from a ADB member country
 - b. Not be under any notice of disbursement issued by the Government and the Asian Development Bank (ADB)
5. To be considered qualification, a contract must
 - a. Have completed in the last **three years at least two** contracts of a similar nature of at least 75% of the value of the bid.
 - b. Have cumulative works turnover in the last 2 years equal to at least 1.5 time the value of the bid price.
 - c. The proposed works manager must have at least 3 years of experience in works of an equivalent nature and volume and no less than one year as managerDocumentary evidence to demonstrate the bidder's qualifications must be submitted with the bid.
6. Bids must be delivered to the address given below at or before **14:30 pm. 20 September 2018**. Late bids will be rejected. Bids will be opened in public immediately thereafter at the same address in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person.
7. The Employer shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
8. All bids must be accompanied by a bid and performance securing declaration as described in the bidding documents. Any bid not accompanied by one will be rejected as non-responsive.
