2. Procurement will be conducted through National Competitive Bidding (NCB) procedures and under the laws and regulations governing public procurement within the Kingdom of Cambodia.
3. This invitation is open to all eligible bidders from eligible source countries as described in TIB clause 4.

Qualification requirements include (i) Documentary evidence of the Bidder's qualification to perform the contract if its bid is accepted to the Purchaser's satisfaction, (ii) In the case of a bidder offering to supply goods under the contract which the Bidder did not manufacture or otherwise produce, the Bidder has been duly authorized by the goods' manufacturer or producer to supply the goods in Cambodia, (iii) That the Bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years of not less than 50% of the bid price in each contract, (iv) That the Bidder has completed contract in the total cumulative amount equal to at least two time the value of the bid price in the preceding two years, (v) That the Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods and as per the other qualification requirements as per ITB sub-clause 14.2.
6. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee USD100.00 or its equivalent in Cambodian Riel being Riel 410,000. The method of payment will be made by either Cashier's Check or Cash. The Bidding Documents will be sent by post or collected in person at the discretion of the bidder. Other than payment of the non-refundable fee specified above; there shall be no other conditions for purchase of the bidding documents.
