**Supply, Delivery and Installation of 48 Standing Booths, 2 Shelves and 44 Table for Booths
for 5 Assessment Centers at BIT-Battambang , PPI, NPIA, RPITST and Kratie PTC**
TVETSDP/G-29-AF-SHP

1. The Royal Government of Cambodia (RGC) has received a loan from the Asian Development Bank (ADB Loan No. 3167-CAM) and additional financing from the Agence Française Développement (AFD Loan No. 8305) towards the cost of Project Name: Technical and Vocational Education and Training Sector Development Project (TVETSDP) and it intends to apply part of the proceeds of the AFD Loan 8305-CAM to payments under the contract for Supply, Delivery and Installation of 48 Standing Booths, 2 Shelves and 44 Table for Booths for 5 Assessment Centers at BIT-Battambang , PPI, NPIA, RPITST and Kratie PTC, TVETSDP-G-29-AF-SHP.
2. The goods are required to be supplied by 8 weeks after effectiveness of contract.
3. Interested qualified eligible suppliers are invited to obtain a copy of the bidding documents free of charge from the address given below by submitting a written application. Except for the submission of a written application, there shall be no other conditions for obtaining the bidding documents.
4. To be considered eligible and qualified a bidder must
 - i) Be from a ADB member country.
 - ii) Have completed at least two contracts for supply of similar goods in the preceding 3 years of not less than 50% of the bid price in each contract.
 - iii) Have completed contracts with a total cumulative value equal to at least 1.5 times the value of the bid price in the preceding 2 years.
 - iv) Not be under any notice of disbarment issued by the Government, The Asian Development Bank or the World Bank
5. Bids must be delivered to the address given below at or before **2:30 pm on 08 April 2020**. Late bids will be rejected. Bids will be opened in public immediately thereafter at the address given below in the presence of the Bidders' representatives and the Project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person.
6. The Purchaser shall award the Contract to the Bidder, whose bid has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
7. All bids must be accompanied by a bid securing and performance declaration as described in the bidding documents any bid not accompanied by one will be rejected as non-compliant.
