**Wishes to engage a contractor to implement the following**

1. The Royal Government of Cambodia (RGC) has received a loan from the Asian Development Bank (ADB Loan No. 3167-CAM) and additional financing from the Agence Française Développement (AFD Loan No. 8305) towards the cost of Project Name: Technical and Vocational Education and Training Sector Development Project (TVETSDP) and it intends to apply part of the proceeds of this ADB and AFD Loan 3167/8305-CAM to payments under the contract for the Demolishing the Old DGTVET Building (TVETSDP/CW-19-AF-SHP).
2. Demolishing the Old DGTVET Building will begin on 28 April 2020 and will be completed by end of 12 June 2020.
3. Interested qualified eligible contractors are invited to request a copy of the bidding documents free of charge from the address given below.
4. To be considered eligible and qualified a contractor must
  - i) Be from a ADB member country
  - ii) Not be under any notice of disbursement issued by the Government and the Asian Development Bank (ADB) To be considered qualification, a contract must
5. To be considered qualified a contractor must
  - i) Have completed in the last **three years at least two contracts** of a similar nature of at least 75% of the value of the bid.
  - ii) Have cumulative works turnover in the last 2 years equal to at least 1.5 time the value of the bid price.
  - iii) The proposed works manager must have at least 3 years of experience in works of an equivalent nature and volume and no less than one year as manager.Documentary evidence to demonstrate the bidder's qualifications must be submitted with the bid.
6. Bids must be delivered to the address given below at or before **16:30 pm. 08 April 2020**. Late bids will be rejected. Bids will be opened in public immediately thereafter at the same address in the presence of the Bidders' representatives and the project's beneficiaries from the concerned local community who choose to attend shall be allowed to be present in person.
7. The Employer shall award the Contract to the Bidder whose offer has been determined to be the lowest evaluated bid and is substantially responsive to the Bidding Documents, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
8. All bids must be accompanied by a bid and performance securing declaration as described in the bidding documents. Any bid not accompanied by one will be rejected as non-responsive.
