The Ministry of Labour and Vocational Training (MLVT), Directorate General of Vocational Education and Training (DGTVET) now invites sealed bids from eligible and qualified bidders for Contracts No. **TVETSDP/CW-20-AF-NCB: Construction of New DGTVET Headquarters**.
2. Procurement will be conducted through National Competitive Bidding procedures outlined in the Procurement Manual for Externally Financed Projects/Programs, and under the laws and regulations governing public procurement within the Kingdom of Cambodia.
